## ❖ **A BRIEF HISTORY OF THE COLLEGE**

A proposal to setup a college to impart general Higher Education to the people residing in the newly urbanized southernmost part of the town was mooted by some eminent educationists in the early part of 1970. A committee of some leading citizens was formed to start the college with the name New Silchar College in nearby Netaji Girls' High School from the academic session of 1971. The need for an Institution of Higher Education in this area began to be generally felt, and two "Sebaiets" of the Estate of the deity Radhamadhab, Late Rajanikanta Saha and Smt. Sefalikana Saha, wife of Lt. Hrishikesh Saha came forward to donate a plot of land, measuring 1½ acres for the purpose, on condition that the college be named after the deity Radhamadhab. So, the college under the name and style Radhamadhab College formally came into existence on 31st May, 1971. Gauhati University granted affiliation to the college upto Degree of Bachelor of Arts in the year 1971. In 1983 the Govt. of Assam extended to the College grants in aid status. The UGC granted its recognition (2f and 12B) in 1992 and since then the college has been receiving UGC financial assistance for various development projects. The college celebrated its Silver Jubilee year in 1996 and through the celebration of Golden Jubilee in 2021, the college has fulfilled its mission in imparting quality education and instilling moral and spiritual values in the students. Since its inception, the University toppers of both Gauhati University and Assam University have added fresh laurels to its achievements and added many a feather to its cap.

## ❖ **LOCATION OF THE COLLEGE**

Surrounded mostly by suburbs, the College is situated in New Silchar area about 2 K.M. away from the main centre of the city, in Silchar-Aizawl National Highway. All types of vehicles ply on the road and there is no problem to reach the college within a few minutes from any part of the city.

## ❖ **AFFILIATION AND RECOGNITION**

Started as a single faculty of Arts in 1971, the college was granted affiliation first by Gauhati University in 1971 for the award of degree in Bachelor of Arts and then it came under the jurisdiction of Assam University Silchar (A Central University) in 1994 when it came into existence. Subsequently, the college was granted affiliation by Assam

University, Silchar for Bachelor of Commerce in 2007. The Govt. of Assam granted the College grants in aid status in 1983. The college was provincialized by the Government of Assam in 2005 under the College Employees Provincialisation Act, 2005

#### ❖ **ACCREDITATION**

Radhamadhab College is the first college from Southern Assam and first among the affiliated colleges under Assam University to be accredited by National Assessment and Accreditation Council (NAAC). The Executive Committee of the NAAC on the recommendation of the duly appointed Peer Team declared the College Accredited with C+ Grade. The college was reaccredited in 2016 (2<sup>nd</sup> cycle) with Grade B. The college is one of the few colleges in Barak Valley which has proudly completed the 3<sup>rd</sup> Cycle of NAAC accreditation with Grade B in 2024.

#### ❖ **MANAGEMENT OF THE COLLEGE**

The college is managed by a body of respectable personalities of the city, under the name and style “Governing Body”, constituted under the provision of Assam Non-Government College Management (Amendment) rules, 2009. Though the body is permanent in nature, but the tenure of most of the members in the body is generally three years. The body is composed of persons nominated by the Govt. of Assam from among the panels of personalities which include in it donor member as well as representatives from teaching, non-teaching staff of the college and guardian members. The University nominates its representative to the body.

#### ❖ **VISION**

The ultimate goal of the college is to make the institution “a centre of excellence in the field of Higher Education”. To achieve this goal, systematic approach, introduction of innovative academic programme and planned approach in infrastructural development adopted in recent years in this institute to produce trained and skilled student for betterment of the society. The college has also introduced meaningful co-curricular activities to generate a sense of discipline, ethical and moral values in the students and centre for extension activities to involve students in community service and to develop a sense of sharing. Participation in literary and cultural competitions definitely brings out the talent and

helping them to develop into whole personality so as to enable them to contribute towards nation building.

### H.S. GUIDELINES

#### H.S. (1<sup>st</sup> Year & 2<sup>nd</sup> Year) GUIDELINES

Two year Higher Secondary Course {Arts & Commerce (Self-Financed)} affiliated to Assam State School Education Council Div.-II and is governed by the rules and regulations of Assam State School Education Council Div.-II. The course comprises of two parts, H.S. 1st year (Class XI) and H.S. 2nd year/Final year (Class XII).

**The scheme of study for H.S. in Arts stream is as follows:**

There will be 6 compulsory subjects in total for all students. A candidate of H.S. Programme of the council shall have to opt for the following:

#### **(a) Core subject**

(i) English - 200 marks (with two papers of 100 marks each)

(ii) M.I.L. (Bengali, Manipuri, Mizo, Bodo, Assamese, Hindi, Khasi, Garo, Hmar) / Alternative English

- 200 marks (with two papers of 100 marks each)

**\*100 marks in the H.S. First year (Class XI) examination and 100 marks in H.S. Final year (Class XII) Examination**

**N.B: Except for Bengali, Manipuri and Alternative English, the rest of the subjects if opted for are to be studied privately by the candidate.**

#### **b) Elective subjects**

(i) Four Elective subjects, each of 200 marks {100 marks in H.S. First Year (Class XI) Examination and 100 marks in H.S. Final year (Class XII) Examination}

**Subjects offered:** Adv. Bengali, Adv. Manipuri, Political Science, Economics, Education, Logic & Philosophy, History, Swadesh Adhyayan, Accountancy & Auditing, Artificial Intelligence, Fine Arts, IT/ITeS, Retail Trade.

(ii) In addition to the two Core subjects and four Elective subjects, a candidate shall have to compulsorily study Environmental Education in Class XI and General Studies in Class XII for 50 marks each. The assessment of the subjects will be done internally and accordingly Grade will be awarded.

**Pattern of Examination:**

The H.S. Final Examination as well as H.S. First Year annual exam will be conducted by the ASSEB Div-II at the Government/Provincialised institutions in consultation with the Lead College of the district and Inspector of Schools.

- The result of the H.S. Final Examination will be determined on the basis of the marks obtained in H.S. Final Examination only.
- No credit of H.S. 1st Year examination shall be counted towards the result of H.S. Final Examination.
- The H.S. Final Examination shall be held in the month of February-March.
- Internal Examinations shall be conducted by the institutions for the students of the H.S. 1st Year and 2nd Year classes to accelerate their regular study habits.
- ASSEB, Div-II will conduct Repeat (Betterment) and Compartmental examination etc. maximum within 3 months after declaration of the H.S. Final Examination results.

#### **UNIT TEST – HALF YEARLY – REVISIONARY TEST**

- The District Examination Committee will conduct Internal Examination of Class XI and XII as per Government Guideline including Annual Examination of Class XI. The Question Papers should be concept based as far as practicable.
- The district Examination Committee will conduct revisionary test (earlier termed as PRE-TEST) for H.S. 2nd Year class through the concerned institutions to assess the student's understanding of previously learned material by providing them with an opportunity to review key concepts and identify areas where further study is needed. The main motto is to help them prepare for upcoming examinations and improve their overall knowledge retention.
- ASSEB will provide a portal to enter the marks secured by each candidate in all the Internal Examination. The student whose marks of Unit Test-1/ Half Yearly Examination of Class XII are entered in the portal will only be eligible to appear in the H.S. Final Examination.

## **PASSING CRITERIA**

### **PASS MARKS FOR H.S. 1ST YEAR EXAMINATION**

- The H.S. 1st Year Examination, a candidate has to pass in both the MCQ type part and descriptive type part of the subject separately with 33% of marks as well as in the practical/project portion and theoretical portion of the subjects, with compulsorily 33% of marks separately.
- ASSEB will issue instructions to Internal Examination Committee to prepare 4 [Four] sets of OMR for selected subjects to conduct the examinations. The list of selected subjects shall be notified time to time.
- After completion of the evaluation of the scripts and online posting of marks of Annual Examination of Class XI, ASSEB will declare the result and e-Marks Sheet will be issued to the students.

### **PASS MARKS FOR H.S. FINAL YEAR EXAMINATION**

- The minimum pass marks is 33% of the total mark for all subjects.
- For a subject having practical/project parts the minimum pass marks shall be 33% of the marks allocated to the theory part and 33% of the marks allocated to the practical/project part.
- In H.S. course curricula, the student must have to appear in 6 [six] subjects and the result will be declared as PASS, only if the students will secure 33% of marks in aggregate, in spite of the fact that even if he fails in one subject. However, passing in English and MIL/Alt. Eng. is compulsory.

**(Relevant abstract of the General Guidelines & Regulations of Assam University)**

### **PROGRAMME OF STUDY UNDER FYUGP:**

The programme of study to be called as Four-year Under Graduate Programme (FYUGP) under NEP 2020 and shall be a 8-semester programme of 4 (Four) years duration.

## **Primary Guidelines for admission to Degree 1<sup>st</sup> semester consequent upon implementation of NEP-2020 by the Assam University, Silchar.**

Assam University has implemented NEP-2020 from the session 2023-24 for UG courses in affiliated colleges with the following guidelines:

1. UG curriculum for colleges affiliated to Assam University shall be a four-year UG programme (FYUGP).
2. UG programme under AU shall be of four-year duration with lateral exit and entry option at various level; viz. Exit after one year (two semester) with Undergraduate Certificate, exit after second year or four semesters with Undergraduate Diploma, exit after third year or six semester with Three Year Bachelor's Degree and exit after four year or eight semester with Bachelor's Degree (HONOURS/Research).
3. Curriculum structure as per NEP-2020 for colleges affiliated to AUS is comprising of the following courses-
  - DSC: Discipline Specific Core.
  - DSM: Discipline Specific Minor.
  - IDC: Interdisciplinary Courses.
  - AEC: Ability Enhancement Courses (Language – MIL (Bengali, Manipuri) & Alt. English).
  - SEC: Skill Enhancement Courses.
  - VAC: Value Added Courses (Common)

  - a) DSM is two types for each subject – first minor and second minor.
  - b) Students shall take two DSM subjects related to his/her discipline from cluster of subjects provided by the College/University.
  - c) For Three Year UG programme DSM-101(3), DSM-201(4), DSM-251(3) and DSM-301(3) =13 credits should be the first minor subject while DSM-151(3), DSM-252(3), DSM-302(3) and DSM-354(4) = 13 credit should be second minor subject. For FYUG programme DSM-401(4) should be first minor subject and DSM-451(4) should be second minor subject.

5. Interdisciplinary Courses (IDC) shall have three (03) baskets viz. Social Science (SS), Humanities (HN) and Commerce & Management. Student may opt for any one from these 04 baskets in each of I, II and III semesters. Bunching of subjects in each basket shall be as per table below.

6. IDC courses opted shall remain same for all three semesters. Semester wise change of IDC is not allowed.
7. DSC, DSM and IDC cannot be the same subject.
8. For VAC 151 (EVS) there shall be no practical component.
9. For Research with Honours students, DSC-451 paper shall be Research Methodology and content of this course shall be the same across the subjects and across the disciplines.
10. Any student interested to opt for **Honours with Research** in fourth year should have **7.5 CGPA upto third year or 6<sup>th</sup> semester without any arrear.**
11. For only Honours degree there shall not be any CGPA restrictions, but students with arrear papers shall not be allowed to move 4<sup>th</sup> year in any case.
12. For only Honours degree in 8<sup>th</sup> semester in lieu of project/dissertation, students shall have the option to take three additional courses as DSC (DSC-452.453 & 454) which will be equal to 12 credits in total.
13. For AEC there shall not be any internal examination and the total marks for AEC examination (ESE) shall be 50 with two hours examination duration.
14. SEC shall have to be opted from either DSC or DSM. (SEC should be offered same subject as the student opted DSC wherever available)

In this regard, students are requested to note the following:

1. Maximum 01 (one) year of gap (if any) will be allowed subject to production of valid and appropriate gap certificate.
2. Only Income certificate issued by the Circle Officer will be accepted for taking admission under Fee Waiver Scheme of Govt. of Assam.
3. Candidates seeking admission from any other board/council (other than SEBA) will have to submit Migration Certificate.
4. It is mandatory for the students to have an email ID with their own name and phone number (An OTP will be sent to this mobile number for login into the admission portal) with whatsApp.

### **FYUGP**

The admission form fill up process will be on-line through SAMARTH e-Gov. Portal. The Commencement of Admission will be notified through College Website and Daily News Paper.

#### ***Procedure of online form Fill-up and Admission***

1. As per notification of Assam University, No. AUD/CDC/CUET-2024/47, Dt. 15/03/2024 issued by the Registrar, AUS, the admission in Four Year Under Graduate (FYUG) courses will be through CUET (UG) from the current academic session. However, the vacant seats (if any) may be filled up with non-CUET candidates by following standard admission process of the College.
2. Candidates have to fill up and submit admission forms online through SAMARTH e-Gov. Portal. ([www.assamadmission.samarth.ac.in](http://www.assamadmission.samarth.ac.in)). Link will be made available in the College Website - [www.rmcollege.org](http://www.rmcollege.org)
3. Merit lists (Course wise) will be uploaded online before admission.
4. All the applicants have to be present physically for document verification and necessary admission process.

5. A candidate must produce the following documents in original along with the self attested photocopies-
  - Mark sheet and Admit Card of the last qualification examination.
  - Age proof certificate
  - Two copies of recent passport size photographs.
  - Cast certificate from competent authority (Wherever necessary)
  - Income certificate from Circle officer (Wherever necessary)
  - An undertaking from the applicant and also his/her guardians that the applicant will not resort to ragging, in any form, must be submitted in the prescribed format at the time of admission.

#### **A) CLASS SCHEDULE:**

Academic session of H.S. class will tentatively begin from June and continues till February of the next calendar.

Holidays and vacation are declared strictly in accordance with Assam University rules of Holiday.

Classes of all courses (H.S & FYUGP) generally begin at 9-00 A.M. and continues till 4-30 P.M. from Monday to Saturday. Students are required to collect their class schedule just before the beginning of the first day of class. Class schedule of all classes is displayed on the college NOTICE BOARD.

#### **B) ATTENDANCE:**

Students of all classes are required to attend lectures of respective classes each of 45 minutes duration. 75% attendance of lectures delivered in each subject is compulsory for all students to be sit for the Final Examination. Students attending less than 75% of lectures are not allowed to sit for the Final Examination of University or Council.

### ***Examination Guidelines:***

1. Students securing highest CGPA (above 6.0) and with no back paper shall be allowed to change his/her core course once only, after completion of second semester. However, if a candidate desires to make one of his/her minors to core then automatic change in the minor should be done as same subject cannot be opted as both core and minor. Also change of core may be allowed only within allied subjects.
2. 7.5 CGPA should be obtained by a student up to 3<sup>rd</sup> year for opting Honours with Research Degree in 4<sup>th</sup> year. However, for only Honours degree there shall not be any CGPA restriction. But students with arrear paper shall not be allowed to move to 4<sup>th</sup> year in any case.
3. Evaluation of 3 and 4 credit courses shall be out of 100 marks and that for 2 credit course shall be out of 50 marks.
4. IDC courses opted shall remain same for all three semesters. Semester wise change of IDC is not allowed.
5. For AEC courses, there shall not be any internal exam. Total Marks for AEC examination shall be 50 with two hours examination duration.
6. SEC shall have to be opted from either DSC or DSM. Evaluation method of SEC for Arts and commerce shall be 50 (End Semester Theory) + 20 (End Semester Practical/Project/Field work) + 30 (internal test of which 20 for test and 10 for attendance).
7. For EVS (VAC-151) evaluation method shall be 70 (End Semester exam) + 30 Internal/Assignment. Marks for Internal test shall again be divided to 20 for written test and 10 for attendance.
8. Evaluation method for VAC-101 (with practical) shall be same as that of SEC (with practical) and that of VAC-101 (Without practical) shall be same as VAC-151.
9. EVS in VAC-151 should be of 100 level and EVS included in Natural Science Basket as IDC should be of 200 level.
10. Publication/Presentation of papers out of Research Project Dissertation carried out in VIII semester is not mandatory. However, the project shall have to be presented before Departmental Research Committee and in presence of an external examiner during end semester examination. Total marks for the project shall be 300 of which 90 shall be internal and 210 is for end semester examination. Out of 90 marks as internal, in case of Dissertation/Project, there shall be three progress reviews and each review shall be of 30 marks. Marks obtained by a student in each of the review shall be notified immediately. Review of progress shall be done by concerned supervisor in presence of Departmental Research Committee.

11. For all other courses evaluation method shall be of 70 marks (for End Semester Examination) and 30 marks (for Internal Examination). Marks for Internal test shall again be divided to 20 for written test and 10 for attendance.
12. For Subjects with practical's DSC-152, DSC-253, DSC-303, DSC-354 and DSC- 404 shall be practical with 100 marks. Practical examination shall be held in presence of External Examiner.
13. For Subjects with practical DSM-251 shall be practical for first minor and DSM-351 shall be practical for second minor. Marks for practical examination shall be 100 each and examination shall be held in presence of External Examiner.
14. For VAC 151 (EVS), shall not have any practical component.
15. For opting DSC and DSM combination, clustering of subjects shall be as per ANNEXURE-III. DSC from one cluster and DSM from other cluster is not allowed. DSC, DSM and IDC cannot be the same subject.
16. All DSM courses shall be stand alone and students can select first minor subject and second minor subject according to their choice keeping total requirement of 17 credit for each minor but they cannot change the code of minor papers viz. one student of Physics (Core) may have Chemistry as first minor in DSM 101 and Mathematics as second minor in DSM 151. But the other student of Physics (core) may have Mathematics as first minor in DSM-101 and Chemistry as second minor in DSM 151.
17. For Research with Honours students, DSC-451 paper shall be research methodology and content of this course shall be same across the subjects and across the disciplines. However, for other students, DSC 451 will be a usual 500 level paper.
18. **Any student interested to opt for Honours with Research should have 7.5 CGPA up to third year without any arrear.**
19. In lieu of MIL, Alternative English may be opted by a student.

## **CENTRAL LIBRARY (BIPIN CHANDRA MEMORIAL LIBRARY)**

The Central Library of the college christened as 'Bipin Chandra Memorial Library' aims to support the academic programmes offered by the parent body and to provide better collection and services to support the academic requirements of the students and the teachers. The library building under UGC VIII<sup>th</sup> Plan on the first floor of the Central Block of the college is housed with 19767 books and 30 journals and magazines, along with a number of leading national and local newspapers. The library has a good Reference Collection including Dictionaries, Encyclopedias, Biographies, Educational Philosophies, Research Methodology, North-East, Religion, Literary Works, Bound Question Papers and a 'Special Repository Centre for Barak Valley', to collect books related to the history, culture and literary heritage of the region.

The library has created an online Database of its total collection using SOUL, 3.0 and is fully automated with computerized processing and circulation services. An Online Public Access Catalogue (OPAC) has been created by the library, through which books can be searched (with keywords) through computer easily, giving exact location of the book in the library. The library provides various modern facilities like Bar code-enabled computerized

Library Card, Internet, Reprography, Inter-library Loan, Online Searching, E-Resources, Consortium-based Services, etc. The library has the facility of Departmental Library for each department, having a separate collection on each subject. The library is also enabled with the facility to access the electronic resources of INFLIBNET Centre, UGC, by registering through the N-LIST Programme (National Library and Information Services Infrastructure for Scholarly Content) of UGC, including 2,100 electronic journals, 51,000 electronic books and several bibliographic databases, which can be accessed by the students of the college through Internet Browser with the Username and Password of the college. The library has established online association with the British Council (Library and Information Services), Kolkata, to avail various facilities like accessing Books and Periodicals, DVDs and CDs, Online Resources, Document Delivery Service, etc. of the British Council, through the Institutional Membership Cards and Login ID and Password of the college. The library maintains a separate web page in the official website of the college, which enables the library to offer its services and to tell its story to its users. Details of library holdings and library services are incorporated in the webpage (Address: [www.rmcollege.org/library](http://www.rmcollege.org/library)).

The library added a new feather to its cap by introducing the Digital Library Section in 2016. The Digital Library of the college uses the DSpace customized Open Software. Also latest facilities like Smart Digital Display, Smart Attendance System with Barcode have been introduced in the library in 2023. A number of downloaded digital objects have been stored in the Digital Library along with educational CDs and DVDs, Photo Gallery of the college, etc. Recently a Digital Library Institutional Repository has been created for storing digitized copies of Prospectus, College Magazines, Newsletters, Question Papers, E-book etc. Also Smart Attendance System for library visitors and Digital Display Monitor have been installed in the library.

A spacious reading room has been provided for the students, with access to newspapers and journals. They are also enabled with free Internet facility for their learning purpose. The library also provides Career Information Service to the students with access to competitive magazines and Employment News in the library, and also displaying various career-oriented information on the Notice Board of the library. The library acts as a centre providing in-house training and practical sessions to the students of DLIS (Diploma in Library and Information Science) course run under the Self-Financing Cell of the college. A Library Orientation Programme is conducted every year to train the students about use of library and library resources, and also as to how to access the electronic resources available in the library. Besides the library has a Book Bank for the financially challenged students, where students can avail the facility of borrowing books for the whole session.

The library is advised and supported by the Library Committee under the aegis of IQAC of the college, to advice in matters of development and management activities of the library. Library activities like Book Exhibition,

Library Best User Award, Library Literacy Programme, Publication and release of Library Newsletter 'Informania', Guest Lectures and Awareness Programmes, etc are being organized with the support of the Library Committee.

The library is open from 9.00 A.M. to 5.30 p.m. on all working days. Students will be issued Smart Library Card from the library at the beginning of the session. For more details students may visit the library.
