NOTICE REGARDING ADMISSION INTO H.S. 1ST YEAR (ARTS & COMMERCE) :: SESSION: 2026-27

In pursuance of the letter issued by Secretary, ASSEB Div-II, vide letter No. ASSEB/DIV-II/R&A/PORT-NOTE./2026/53/2329 Dtd. 10/04/2026, the online applications for admission into H.S. 1st Year (Arts & Commerce) will be starting from 12/04/2026. The detail timeline of the admission process (as issued by ASSEB Div-II) is enclosed with this notice. Candidates willing to take admission are hereby directed to follow the various instructions mentioned below.

- Candidates are directed to apply online via Darpan Website (Link: <https://darpan.ahseconline.in/>) as no other mode of applications will be accepted.
- Seat Capacity for Arts stream is 340 and for Commerce stream is 150 Nos.
- Selection of candidates for admission will be strictly based on Merit
- Reservation rules will be followed for SC, ST, OBC & MOBC candidates as per Assam Govt. policy
- Candidates seeking admission from any other board/council (*other than ASSEB, Div-I erstwhile SEBA*) will need to submit Migration Certificate
- A maximum gap of 02 years will be allowed upon submission of valid gap certificate

The provisional selection list/waiting list of the candidates, who will apply for admission will be published on **25/04/2026 at 10:00 A.M.** The selected candidates will have to accept the admission offer from **25/04/2026 to 27/04/2026**. After acceptance of the same the candidates will have to visit college between **28/04/2026 and 08/05/2026 (from 11:00 A.M. to 04:00 P.M.)** with xerox copies along with original copies of the following documents:

- DARPAN ARN Receipt
- Income Certificate of Parents issued by the Circle Officer or Ration Card issued by Govt. (if availing Fee Waiver Scheme and only applicable for Arts Stream)
- HSLC Admit and Marksheet
- Caste Certificate (whereas applicable)
- Migration Certificate (whereas applicable)
- Gap Certificate (whereas applicable)
- Aadhar Card/PAN Card



All candidates seeking admission in Arts stream (who are not availing Fee Waiver Scheme) and all Candidates of Commerce stream (which is Self-financing) will have to pay the requisite admission fees of ₹ 3,250.00 only.

In case of candidates seeking admission in Arts stream (under Fee Waiver Scheme) will not need to pay any admission fees.

All candidates who will take admission will have to procure uniform (as per colour code) from the vendor on the day of admission itself after paying necessary charges as mentioned below:

The students will be able to submit their applications through online for admission into different institutions by visiting www.darpan.ahseconline.in or www.ahsec.assam.gov.in. The concerned students and institutions are advised to go through the given guidelines/SOP, important dates in detail for compliance and smooth conduct of the admission process.

GUIDELINES/SOP FOR INSTITUTIONS:

Sl. NO	GUIDELINES/SOP FOR INSTITUTIONS
1.	After verification of applications, the Selection List and Waiting List for admission into IIS first year will be prepared by the institutions concerned.
2.	Selection List and Waiting List for admission will be made available in the portal (www.darpan.ahseconline.in) for the students. Moreover, candidates will also receive notification of their selection through SMS.
3.	The Institutions are to ensure that physical verification of documents shall be conducted at the time of admissions into IIS First Year courses.
4.	Once a selected student accepts the admission offered by the institutions, the institutions will have to click the "Confirm admission" button to complete the admission process in the portal using Institution Login ID on daily basis during admission process latest by 08/05/2026. The institution will be able to confirm admission of only those students who have accepted the Admission Offer. The institutions will be able to change the preferred subject(s)/Stream of a student at the time of admission only with due consent from the student and the institution concerned will have to update the same in the portal on the day of admission. Moreover, change/modifications in the stream and Subjects of students will be available in the DARPAN portal even after the admission process is over for duration as stipulated by ASSEB, DIV-II in due course.
5.	
6.	Institutions should refrain from getting students admitted without his/her consent.
7.	Institutions are not allowed to enroll students through other institutions so as to avoid complications for processing other mandatory process in respect of students.
8.	All institutions are hereby notified that admissions process must be completed within the stipulated timeframe. Failing which, the institution will have to pay a fine of Rs 5000/- each day for confirming admission on the portal.
9.	Institution must ensure to confirm admission of students from enlisted boards only.
10.	Issuance of Gap permission certificate from ASSEB, DIV-II for admission into IIS 1 st Year Class has been discontinued from the Session 2025-26. Hence, such students who are seeking admission after a gap period will be admitted by the institution concerned after proper verification of documents, reasons of gap and eligibility. Such cases should not be referred to ASSEB, DIV-II.
11.	Subject permission is not required for selection of subjects by the institution on DARPAN portal. Please check notification issued vide- ASSEB/DIV-II/Course Curricula/2025/007/556 dated 05/04/2025.

GUIDELINES/SOP FOR STUDENTS:

SL. NO	INSTRUCTION FOR STUDENTS
1.	An Applicant has to submit application online through "DARPAN" Portal.
2.	A student can apply up to maximum of five (5) no. of applications.
3.	To edit profile of a student, he/she can visit the PROFILE TAB in the student dashboard before preparation of selection list by the institution. The profile of a student can be edited only once.
4.	The published Selection List and Waiting List for admission into IIS first year will be made available in the DARPAN portal for the students. The students will be notified of their selection through SMS.
5.	After publication of selection list, candidates will be allowed to approve only one institution for admission using their login id in the portal. The candidate must take admission in the institution concerned within the stipulated time period to complete the admission process.
6.	A student will be able to change their preferred subject(s)/Stream at the time of admission. Students will be able to change their preferred subject(s)/Stream at the time of admission and the institution concerned will have to update the same in the portal on the day of admission.
7.	If a student does not accept the admission offer within stipulated time, the student will be removed from Selection List with information through SMS.
8.	If a student does not apply/select any institution within stipulated time of opening of DARPAN portal, the student's name/ profile will be disabled on the portal with information through SMS.
9.	Mobile number should be unique for registration of student on DARPAN portal. Same mobile cannot be used for multiple applications.
10.	Issuance of Gap permission certificate from ASSEB, DIV-II, for admission into IIS 1 st Year Class has been discontinued from the Session 2025-26. Students are advised to consult with institutions for their eligibility for admission.

Note: The Registration process for Session 2026-27 is scheduled in the month of June, 2026.
