Temporary Arrangement/Guidelines for imparting education to final year students of colleges in physical mode (From 1st week of Sepetember 2020 subject to the situation)

For colleges having HS/UG & PG:

1. Students of final year i.e. fifth semester UG may choose to attend educational institution which is nearby to his/her residence. In such cases the student should inform his/her own institution and the Head of the institution where he/she proposes to study.
2. Students of final year class 12 may choose to attend educational institution which is nearby to his/her residence. In such cases the student should inform his/her own institution and the Head of the institution where he/she proposes to study.
3. Students of MSc 3rd Semester have to attend own institution
4. The Head of the institution must arrange the seating arrangement of students in such a way that there is a minimum physical distance of 6 feet between each student. Each student has to wear masks as per norms. In a classroom there should not be more than 25 students subject to maintaining the physical distance. Accordingly a class has to be divided onto sections and classes arranged
5. In order to avoid overcrowding, the entry and exit of timing of students has to be regulated. Several models may be followed for carrying out classes

For institutions having single streams the class timings may be extended keeping in mind the physical distancing norm and avoiding overcrowding

**Instead of opting for conducting classes on the basis of streams the Head of the Institution may decide to conduct classes on the basis of subjects in order to ensure the physical distancing norm and avoiding overcrowding

6. For Colleges having MSc the Head of the institution has to allot classes keeping in mind the physical distancing norm and avoiding overcrowding.
